Applications Now Open for USEF Endurance Competition and Licensed Officials Grants

Lexington, Ky. – US Equestrian is now accepting applications for the Endurance Competition Grant and Endurance Licensed Officials Grant. Applications for both grants are due February 1, 2024.

<u>USEF Endurance Competition Grant:</u> The purpose of this grant is to support U.S-based FEI endurance competitions in order to maintain a healthy calendar of competitions within the U.S.

<u>USEF Licensed Officials Grant:</u> The intent of this grant is to support USEF endurance licensed officials and maintain a healthy number of officials licensed in the U.S. The grant offers financial support for USEF endurance licensed officials who are seeking education and experience.

USEF Licensed Officials Grant Application (can be used in addition to the above USEF Endurance LO Grant)

The <u>2024 Licensed Officials Grant Application</u> is officially open. The application deadline is March 1, 2024.

The Federation offers licensed official grants to applicants and current officials wishing to apply for a promotion. These grants are intended to reduce financial barriers for USEF or U.S. FEI officials to complete application requirements.

Individuals should take advantage of this opportunity to attend a training session or apprentice at a location where they would normally not be able to travel. Grants shall not be used for maintenance requirements and can only be received once per competition year.

Individuals can apply for one of two categories – a general grant or U35 grant. General grants will be considered based on the competition environment need for more officials, or higher-level officials. The U35 grants provide an opportunity to support individuals under the age of 35 to become a licensed official or apply for a promotion.

Endurance 2024 Rules

2024 USEF Rulebook Endurance Chapter

Changes from the 2023 rules are printed in red.

Extraordinary and Rule Clarifications going into effect on February 1, 2024:

- EN105.4 (Tracking 88-23): Allowing crew point changes to be made by competition management if needed due to weather or course restrictions.
- EN110.2 (Tracking 89-23): Allowing for alternative accommodations for a finish line if needed and approved by the event steward.
- EN117.3 (Tracking 90-23): Clarification that the term "rider option" is the same as "retirement."

2024 FEI Endurance Rules

Clean Version Marked-up Version

Highlights of the changes for 2024 are outlined below. (See full rules for all changes.)

- CIM categorization for CEI2* when applicable (803.1)
- The winner of a Dead Heat must be determined by the tip of the nose of the Horse that crosses the finish line first. (809.4)
- Should an Athlete wish to retire their Horse at the end of a Phase, the Horse must be presented to the Vetting Area and pass all required Inspections. The maximum time a Horse has for Retirement after completing a Phase is its hold time plus 15 minutes as per Article 807.5. (809.5.4)
- The number of required loops per day for a multiday 2* ride has been reduced from 3 to 2, 3 loops/day are required for a multi-day 3*. (814.4.3)
- Under Heart Rate Assessment, at the first Vet Gate and onwards, except for the Final Inspection, all Horses entering with more than 10 minutes recovery time must pass a compulsory re-inspection. (816.6.5)
- Any shank (lever arm) on any bit may not exceed 10 cm, this has been increased from 8cm. (825.2.5)
- Changes within the CEI Qualifications rules. (833)
- Changes to the Average Speed rules. (837)
- Where a Foreign Official is required for an Event, such Foreign Official may not be a national or resident of the country where the Event is staged, unless that person is resident in a different time zone to the time zone of the Event location or in a different province/state that is at least 500 kms/8 hrs by road from the location where the Event will take place. (848.4)
- Changes within the Disciplinary rules (Chapter IX)
- The person trotting the Horse must lead the Horse from the Horse's left-hand side on a loose rein beside the Horse and not in front or behind the Horse (see Annex 8). (Annex 5 9.7.a)
- Changes within the Officials Required for Events rules (Annex 6)

The USEF Selection Procedures for athletes interested in competing at the 2024 FEI Endurance World Championship in Monpazier, France, have been updated and are available on the endurance page of USEF.org. The FEI Endurance World Championship will take place in Monpazier, France, on September 7, 2024.

Endurance athletes who are considering applying to compete in the FEI Endurance World Championship for Young Riders & Juniors or the FEI Endurance Pan American Championship for Seniors and Young Riders & Juniors in 2025 are encouraged to review the selection memos for these events, which are now available on the endurance page on USEF.org.

The 2025 FEI Endurance World Championship for Young Riders & Juniors is scheduled for September 5-6, 2025, in Buftea, Romania. The FEI expects to announce the dates and location for the 2025 FEI Endurance Pan American Championship soon.

The selection memos for both championships provide important information on selection, including requirements for qualifying events as well as the ranking formula that is used to determine qualification for the U.S. Endurance Team at these events. Please note the information is based on the recommendations of the USEF Endurance Sport Committee and is subject to change due to final approval of the full selection procedures by the USEF Board of Directors or USEF Executive Committee.

USEF Changes for 2024

Online Passport Service Application

- USEF has launched a new online passport service application to be used for services that do not require the passport to be mailed into the office including:
 - 1. New FEI/National Passports
 - 2. Revalidations
 - 3. Duplicate (lost) Passports

- Through this online application, you can sign, pay for, and submit completely
 online through your <u>USEF Member Dashboard</u>. You can also add life recordings,
 expedited service, and UPS Next Day Air.

FEI Registration Price Increases for 2024

- FEI Horse Registration: \$35
- FEI Rider Registration: \$35
- FEI Registration application can be found on the <u>USEF Member Dashboard</u> at this link: https://members.usef.org/fei/horse-registration/horse-select
- Requirements for FEI Horse Registration:
 - All USA-owned horses must have a current life USEF recording before registering with the FEI.
 - All FEI competing horses must have a valid passport. Initial FEI registration requests will not be issued until the horse's passport has been approved.
- Requirements for FEI Rider Registration:
 - All riders must have an active, competing membership before registering with the FEI.
 - A current Code of Conduct and Waiver must be signed, and Safe Sport Training must be completed.

Influenza Vaccine Requirements Changing for January 1, 2024

- As of January 1, 2024, the initial primary series of influenza vaccines consists of two vaccines administered between 21-60 days apart. A booster vaccination must be administered within 6 months and 21 days of the second dose.
 - This change applies to any new primary series started after January 1, 2024.
 An up-to-date passport showing a primary series between 21-92 days apart and a third dose within 7 months, given prior to January 1, 2024, will still be considered valid.

Updated U.S. FEI Entry Quick Guide

- US FEI Entries All withdraws and horse changes need to be made through the USEF Athlete Dashboard as of January 1, 2024
- Important reminder-please make sure you are completing your entry for each FEI competition with both USEF and the competition.

Result Requirement Reminders

The email addresses of riders and owners must be included in the competition results that are submitted to the Federation.
