

Part VII of the USEF Bylaws provides a process by which a complaint may be filed against the Federation by a Life, Senior Active, or Parent of Junior Active Member, alleging that the Federation has (i) violated a Federation Bylaw, rule, regulation, or policy, or (ii) failed to comply with its obligations as a National Governing Body under the USOPC Bylaws or the Sports Act. This complaint form must be used to file such complaint.

A complaint that is not filed in accordance with Federation Bylaws shall render the filing ineffective and the complaint shall not be considered to have been properly filed. The complaint shall be filed with the Federation Regulation Department at disputes@usef.org. At the time of filing, Claimant must also serve a copy of the complaint on president@usef.org and generalcounseloffice@usef.org. The Bylaws are published on the Federation website at www.usef.org Any questions should be directed to the Director, Regulation Department at epratt@usef.org.

Bylaw 707 prohibits retaliation against anyone who files a complaint or report under the procedure in the Bylaws. Retaliation is considered a violation of the Federation rules and grounds for discipline.
