Per HJ102, All competitions must meet the Basic Standards set forth in HJ100 through HJ107. Regardless of rating, additional requirements apply (HJ108) when Horse Entry Numbers exceed five hundred (500) and/or licensed series of competitions are scheduled for a period of twenty-one (21) days or more without a break of at least five (5) consecutive calendar days.

A competition must apply for an exception to any competition requirement outlined in HJ105-108 if management is unable to remedy facility limitations or space constraints due to extenuating circumstances at the facility, beyond reasonable control of competition management. The application for exception must be submitted at the same time as the competition's license application or license renewal on a form provided by the Federation.
